2. Approval of the minutes from the April 6th meeting (Sent previously)

Motion: Approve the April 6, 2023 meeting minutes

3. Chair's Remarks (JT)

I think that you all are doing very well and have found your niches on the board.

4. Conductor's Report (JK)

We have 160 members.

We are lacking in some sections like trumpets. We need to balance the bands for September.

Sectionals on Thursdays is not working. Few people are showing up and its hard on the coaches / conductors to be at band multiple days of the week. We need a better solution. Need to promote the NHB sessions and provide links to other learning.

The Conductors really appreciate Meeta and her team's efforts for keeping the music library organized.

Liftlock NHB still has some of our music, while we have the scores. We should try to get these piece back.

There needs to be a policy about people moving from one band to another. Mark sets up the rosters in late summer and one of the criteria he uses is balancing the instrumentation between bands. If someone moves from one band to another, the balance is thrown off. People cannot just move from one band to another. We need a policy and members need to know the policy for moving to other bands. Maybe have a sign off form so both conductors and Mark know.

We also need to standardize band seating. Conductors will develop 2 layouts, one with three rows and one with 3.5 rows. Conductors will send the layout for September.

Concert stage seating a challenge.

No text description of the concert pieces will appear in the program. Justin / Medda will prepare a list of all the percussion needed to be moved to Cavalry for the concert. Music order and list needed to be sent to Maria before May 12.

Would like the length of rehearsals to be 2.5 hrs.

Need a dialogue committee meeting in August, so September items can be addressed in time.

Need survey to know what band and instrument people will be doing before August to help build roster, to give to Mark to build bands.

No update on the Wilmot Creek exchange.

Action:

- Quinten will find out if Calvary has smaller chairs, need 36-40

5. Finances

5.1 Financial Update (CB)

It is estimated that we will have \$4000 at the end of the month. So not dipping into the reserves.

5.2 Budgeting for 2023-2024 (QD)

It is hard to anticipate all possible expenditures: will we need a shipping container for storage; another drum kit for Green band? Fees should be calculated to cover known/predictable expenditures. Reserves should be preserved for unexpected expenditures.

6. Business Arising from the Last Meeting:

6.1 Concert preparations (BM, JT)

Current Status:

Venue sent insurance certificate. Tickets are being distributed to members and LAWS. Eventbrite set up. Decided to not have a group playing before the concert. Masks will be on hand but not required. Concert flyer available and the concert is being publicized. Advertisements for the program being solicited and the program being created. Poster and guidelines for getting advertisements available and being circulated. MC Heather Thompson is preparing. Movement of equipment has been arranged. Renee is coordinating the set up at Calvary and did go with Sal to review

the stage set up. Considering doing a silent auction since L&M has donated something. Trying to figure out how to do reserved seating.

Board discussion:

John has tape for reserved seating.

Discussed video taping the concert, might cost \$75. Because we are using SMUGMUG we can use HD recordings. Prefer a maximum of 3 people to video tape. If we got raw footage from several angles of the concert, we could edit it into smaller sections for various purposes.

We paid for a technician at the February concert, so maybe they can tape the audio through the sound system.

Would be great if we could video tape Information Day. Could have it on Youtube and our website for publicity.

Action:

- Bev will let Renee know John has tape.
- Quinten will ask about filming/recording at Calvary.
- James will ask members for volunteers or suggestions on people to videotape.
- **6.2 Document Archiving project update (BM):** No update. Busy with concert.

6.3 Venues (JT, JB, QD)

6.3.1 Grace.

Grace Board has resigned and the National Commission of the United Church has taken over. Grace was not favoured in the survey of members. Parking, sound and stairs were the key issues.

6.3.2 Living Hope

Discussing with them but not hopeful. No storage there. Rent might be more because of possible government regulations.

6.3.3 Navy Club

John will push for an update on the other building

6.3.4 Other places suggested in survey: Westdale, Murray Street, Synagogue, Sherbrooke Heights Alliance, Christian Victory, Calvary, etc.

James, Quinten and John have been investigating. A lot of them are either already booked or we would disturb other groups there. Will continue investigating.

6.4 Summer Band (JB)

Survey indicated there was a strong interest in a summer band. Need a Conductor. Mark not sure if he is available. We should follow our policy regarding hiring a conductor.

Motion: Ok for James to proceed with booking a location to hold summer band

Motion: Will consider this as a concert band, so all are PNHB members and covered by our insurance and fees calculated to help with our other costs and not be treated like an ensemble financially.

Motion: Formulate an end of the year survey for the board to approve later **Voting:** Moved by: James Seconded by: Cindy All in favour: passed

Action: James to prepare a survey for the next meeting.
